STALLION SERVICE AGREEMENT for COOLED TRANSPORTED SEMEN

This agreement is made by and between Gastineau Quarter Horses and _____ for the breeding season of 2018 to the stallion ***Ima Zippo Good Bar***. The Mare to be bred _____ Reg. # _____. Purchaser may not substitute another mare without permission of Gastineau Quarter Horses. The following fees are applicable: A nonrefundable booking fee of \$ 250.00 is due at signing and acceptance of this contract. Balance of Breeding Fee of \$ 550.00 must be paid before semen is shipped. The cost of the first shipment of semen is included in the Breeding Fee. Subsequent semen will be shipped at the cost of \$ 250.00 per shipment. It is recommended that the breeding be done at a Qualified Breeding Facility or under the Supervision of an Approved Veterinarian/Breeding Center. The Mare Owner or Representative must notify Gastineau Quarter Horses when the Mare comes in heat. Gastineau Quarter Horses must be given 24 hours notice when semen is needed. The Mare Owner must request shipment cancelled prior to 10:00 a.m. (Central Time) on the shipping day.

Return of Service: Purchaser shall not be entitled to a refund of fees. Live Foal Guarantee: Live Foal means the foal shall stand and nurse. Mare Owner agrees that stallion owner does not make any guarantees, as to the quality of conformation of the foal. It is understood that if the mare proves barren, or aborts her foal, or if the foal is stillborn, a return season will be guaranteed the following year only, providing a written certification is signed by a licensed veterinarian within 7 days. Semen Collection and Shipping Fees will be charged. There will be no right of return to the stallion, if mare is sold, without permission of Gastineau Quarter Horses. Semen shipping days are Monday, Wednesday and Friday.

When Gastineau Quarter Horses signs and returns a copy of this offer, it becomes a binding contract of both parties; subject to the above terms and conditions. This contract shall be construed in accordance with the law of the State of Missouri. The parties agree that all litigation shall be held in the Circuit Court of Callaway County, Missouri. The parties consent to the jurisdiction of the Circuit Court of Callaway County, Missouri, and agree that any service process must be by registered or certified mail. Shipped Semen requests will be filled in the order received. Association futurity breeding or incentive programs with discounted breedings will be accepted for shipped semen. I certify that I am the sole owner of the Mare or have authority to enter into this contract on behalf of the owner(s).
